

#### NATIONAL AGENCY: -

The National Agency is the person who creates a team of Global Agencies, Freelancers, Assistant Legal Advisors, Business Journalists and team who recommend Awardee Persons. National Agency will get 2 to 3 Percentage or as decided by ADF Management from time to time of the business fees submitted by his/her team. Incentives of National Agency can be changed at any time without any prior notification. The National Agency is expected to pay Rupees 4720 /- including GST as Award Contribution Charges. Financial Benefits can be checked once payment is paid and the panel is active.

#### Global Agency: -

Global Agency is the person who gets his website developed by the ADF IT team. With their brand name Global Agency can create unlimited Freelancers, Business Journalists and Assistant Legal Advisors. Global Agency can add or delete any University/College on his website. Global Agency can fix the financial benefits of his team as per his wishes. Global Agency can work as a Training center for IT Placement Courses and online study from the USA. Training Centers will get incentives of Rs. 150 \$ per student for UPI Board America students and Rs. 3000 per student of IT Placement. Global Agency is entitled to get Rs. 20000 Per student of IT Placement and 750 \$ per student for UPI Admissions. Fees for all UG/PG/PG Diploma in Regular Mode will be Rs. 1,50,000 to 1,70,000 depending on university which includes Hostel and Mess Charges also. However, in online mode fees for all IT Placement Courses will be Rs. 1,30,000/- Annual. Fees for UPI Board for all UG/PG courses is 6500 \$. After passing a minimum of 48 credits from the UPI Board, students become eligible to apply to more than 3000 Universities and colleges worldwide. Fees for websites will be 12000/- +GST Applicable. Global Associate may work for placements abroad also.

#### Freelancers:

Freelancers are entitled to provide any admission, legal case, awardee to get honor in a function. Freelances will get up to 30% share in online and distance admissions. For It Placement courses freelancers will get 10000 per student and UPI Board will give them 600 \$ per student.

#### Business Journalists: -

Business Journalists can recommend awardees for three different categories: 1. 8000 to 25000 2. 25000 to 50000 3. 50001 to 100000. Business Journalists will get 40% of the collected amount as incentives. However, interviews of such business journalists will be published for free on the news portal [www.rainbowedumirror.com](http://www.rainbowedumirror.com). Business Journalists will get support of leads if any available for their area. Business Journalists are expected to pay Rs. 4720 INR including GST as a contribution to the award ceremony.

Assistant Legal Advisor: -

Assistant legal advisors can recommend any case for Motor Accidental Claim Tribunal, Bail/quashing/direction from any High Courts of India/Supreme Court of India. Assistant Legal Advisors are expected to pay Rs. 4720/- as a contribution to the award ceremony.
